# Background

Sweden is having general election September 9 2018. During recent years, other countries have been subjected to foreign information influence campaigns against their elections. ISD and LSE have studied these campaigns and possesses unique international academic competence on the subject of foreign influence activities targeting national decision-making. In 2017 ISD and LSE made an in-depth study on influence activities targeting the German election in 2017. MSB has had a dialogue with LSE and ISD regarding the possibilities to conduct a similar research project to identify and analyse

To ensure that the project in itself will have no effect on the ongoing election in Sweden, the outcomes of the research project will not be publicised before the election on September 9, 2018.

# Entering into effect and duration

This project agreement will enter in to force on the date it has been signed by duly authorized representatives for both parties. It will thereafter remain in effect throughout the duration of the project, until ISD/LSE fulfil the obligations under this project agreement, at the latest on the 31st of October 2018, unless terminated in accordance with this project agreement.

#### **Price**

The price for the fulfillment of this project is 173.000 GBP.

# Ethical research approval

Since the research project will study behavior and messaging in social media, it has to be ethically approved by relevant institution/function for ISD and LSE. MSB request to have the approval sent to the MSB contact person.

# **Documentation**

The result of the research project will be submitted as a full project report and an executive summary to MSB contact person. The full project report and the executive summary will be made available to the public.

Unless approved by MSB, the delivery of the full project report and the executive summary shall not constitute a fulfillment of this project agreement.

# Right to the project results

ISD and LSE has the ownership of the results of the project.

MSB has the right to freely use the results of the project.

MSB has the right to process, transfer and disseminate the results of the project. Any need for the protection of patent or unique scientific material of ISD/LSE, should be considered, in regards to handling by MSB of the results.

## Delay, deviation and termination

#### Delay

ISD shall immediately inform MSB contact person if there is a risk of delay or in case of delay of the fulfillment of the project and its outcomes. If MSB accepts the delay, both parties shall agree to a delivery plan for the project. If MSB is not informed about the delay or if MSB does not accept the delay, MSB has the right to a price reduction equivalent to 5 % of the price indicated above for every week of delay and has the right to terminate the project and this project agreement.

### Deviation

MSB shall inform ISD if the outcomes of the research project deviates from the accepted proposal and MSB conditions for the project, in order to facilitate ISD to repair the deviation within reasonable time.

If repair is not conducted within reasonable a time, MSB has the right to reduce the compensation.

#### Termination

This project agreement may, at any time, be terminated by either party with 30 calendar days written notice to the other.

The obligations assumed by the parties under this project agreement shall survive the termination of this project agreement to the extent necessary to permit the orderly conclusion between the parties, hereto and the settlement of contractual liabilities that are required.

### Significant changes in the organisation of the parties

Both parties has the right to terminate the project if a significant change has occurred or will occur regarding its organization and this is of importance to its possibility to fulfil its obligations under this project agreement.

# Force Majeure

Neither party will be liable for any delay in performing or failure to perform any of its obligations under this project agreement if such delay or failure is caused by *force majeure*, such as civil unrest, war, natural disasters or other circumstances that are beyond the control of the party in question. In such event, the party will give immediate notice in writing to the other party of the existence of such cause or event and of the likelihood of delay.

# Monitoring Foreign Influence Campaigns Targeting Sweden

A research proposal from LSE Arena and ISD

May 2018

The second strand will rely on qualitative analysis techniques. This research strand would analyse the content being pushed by the networks identified in the first research stream; we propose to monitor Swedish broadcast and social media to identify narratives used to discredit Sweden and identify any specific examples of disinformation campaigns.

The research team also proposes to complement the above research – which focuses on foreign influence campaigns which target Sweden specifically – with an international component. This strand would monitor social media – and, budget-permitting, broadcast media – in other high priority countries to measure any smear campaigns used to undermine Sweden's international reputation. Initial countries selected for media analysis are: USA; Germany; Russia; UK. Please note these are subject to revision.

- Confirmation from MSB over possibility of immediate press release/short briefing on overarching findings of research after the election to garner media interest for the final report.
   MSB comment: The MSB confirms that this is a good idea, but we would have to have some coordination before of course.

I hope you are both well. I have a quick question regarding media coverage relating to the Swedish election.

We have obviously kept the research over the past two months private, and have not made anyone aware of the project or its funding, as requested in the contract. However, ISD and LSE would usually speuk to trusted journalists following an election, to make them aware of key findings from the research. We are often contacted proactively by media outlets for comment after elections, especially when the far right have performed well, given our reputation for research on these topics.

I know we discussed releasing a brief press release following the election on Sunday. We can of course clear the contents of this with you for sign-off first thing next week. Given our findings have shown very little activity from foreign actors targeting the election directly, and pending any massive changes in the coming week, the key findings would most likely highlight:

- 1. the international far right's mobilisation in the smear campaign against Sweden
- 2. the international far right and Kremlin media's support for the Swedish far right
- 3. the 'alternative media' ecosystems used both internationally and domestically within Sweden to promote misinformation about Sweden and Swedish politics, particularly around migration issues.

Firstly, would you prefer MSB's funding of the work to be transparent in that initial short press release, or would you prefer us not to mention MSB's support of the research? Second, on the back of that press release, would you be happy with ISD and LSE responding to requests for interviews or reaching out to trusted media partners to highlight the research that we have conducted? This could be done either with transparency over the funding of the research or in a more controlled manner, in which we would not need to discuss the project as a whole and disclose the funding from MSB.

I'd be happy to discuss this with you in-depth on Thursday during our call, but it would be helpful to know in advance if we are able to talk to journalists about the research in advance, so that we can make any preparations needed as soon as possible.

Thank you so much for hosting us and for such an interesting discussion. I have so enjoyed getting to understand much more about Swedish politics (the good, the bad and the ugly!) and am glad that you and your team found the insights useful and interesting.

Your points are all very helpful. I have considered most of them for the final report already, for example the limitations issues and clarity on definitions and methodology. I didn't want to overload you with the details of every method of online analysis that we did yesterday, as it would have taken a lot of time away from the discussion, but hopefully when you see the final report you will get the full run-through of methods, approaches, definitions and limitations! It is certainly important for us to point out both that this was purely an online research project and that it was limited by public data access and capacity to monitor platforms on an ongoing basis over two months.

However, I had not considered what we were defining as 'mainstream' or established media as carefully as I should have yet, so I will talk with Peter on what our technical parameters for that definition should be and make sure that it is in line with how we classified outlets in the research process.

I forgot to send through the additional presentation on the Twitter-specific media classification work, so I have attached it here. That hopefully provides more detail on the methodology we used for classifying shared articles. Please do share this with anyone in your team who is interested, but not beyond MSB for now. If you or other team members at MSB would like to see any of the datasets that we collected and used for pieces of the research, for example the 4chan data that we have coded over the past two months relating to Sweden, then please let me know and I'm sure we can send that through.
